#### Admission Counseling (2<sup>nd</sup> ROUND) For Admission to Bachelor of Physiotherapy (BPT) 2025 – 26 (Merit Quota Seats )

The 1<sup>st</sup> round of counseling for admission to **Bachelor of Physiotherapy (BPT)** program 2025-26 was held on August 03, 2025, Sunday. For this round candidates from Merit Number 001 to 250 were called.

In the 1<sup>st</sup> round, merit seats (85) of MGM School of Physiotherapy, Kamothe, Navi Mumbai have been completely filled and thus there is no vacancy at MGM School of Physiotherapy, Kamothe, Navi Mumbai.

In this 1<sup>st</sup> round, the position of seats at MGM School of Physiotherapy, Chhatrapati Sambhajnagar is as follows:-

(Candidate reporting to Chhatrapati Sambhajnagar will not be considered for counseling)

**Important Note:-**

1. All the candidates are hereby informed that they must remain present for the counseling as per the date and timings shown above. Only one parent will be permitted along with the student to avoid crowding. Students / Parents may have to remain present for longer times on the day of counseling to complete the process.
2. Candidate must produce the **Demand Draft** and all the required **original** certificates & two sets of self-attested photocopies of each of the documents as listed below at the time of counseling.
  - ✓ Admit card of MGM UG CET – 2025
  - ✓ SSC Passing Certificate (SSC Statement of Marks will not be accepted)
  - ✓ HSC Statement of Marks **OR** HSC Passing Certificate
  - ✓ Leaving Certificate or Transfer Certificate from previous College.
  - ✓ Nationality Certificate and Domicile Certificate **OR** photocopy of valid passport
  - ✓ Aadhar Card (Photo copy)
  - ✓ Medical Fitness Certificate (Certificate from registered Medical Practitioner) (No fixed format for it)
  - ✓ Copy of Gazette Officer in case of name change of candidate
3. **If the seats get filled completely midway, then the counseling process will be stopped immediately and remaining students present on that day will not be considered for admission counseling. All such remaining students will not have any claim for admission merely because they presented themselves for counseling. All such remaining students will only be considered for round 3 of counseling if vacancy arises in due course of time for which separate notification will be issued.**
4. The candidate should pay the Tuition Fees of first year in the form of Demand Draft only. **No other mode of payment will be accepted.** Demand Draft must be made in favor of **“MGM Institute of Health Sciences” payable at Mumbai.** Multiple DD's in different denominations are allowed in case a single DD for the total 1st year tuition fee is not feasible.
5. After due scrutiny of the original documents, Demand Draft and payment confirmation of 1<sup>st</sup> year tuition fees, provisional admission letter will be issued to the student on the day of counseling. Student is expected to act as per directions mentioned on the provisional admission letter. Without payment of 1<sup>st</sup> year tuition fees in full, admission will not be granted and such student will not have any claim for admission.
6. Students himself/herself must be present to the counseling venue. **No proxy will be allowed in any circumstances.**

7. Due to limited parking capacity in the campus, students/parents may not be allowed to park their vehicles inside the campus.
8. Photocopy and Canteen facility is available in the campus on paid basis.
9. All provisionally admitted candidates need to report to the college immediately for completion of the admission formalities.
10. Candidates are requested to strictly adhere to counseling schedule which is put up on University website.
11. Kindly be aware of the fake websites and the old notifications available through google search. Only the latest notification available on official website of the University needs to be followed. Further refresh the pages as and when official website is being viewed.
